

## **PRIVACY NOTICE UNDER ARTICLE 13 OF THE REGULATION EU 2016/679 (GDPR)**

We inform you that, pursuant to article 13 the European Regulation on the protection of personal Data 2016/679 (hereinafter "GDPR" or "Regulation"), your personal Data will be processed as follows:

### **1. Controller and contact details**

### **3. Source and type of personal Data collected**

3.1 CRIF S.p.A. developed a digital initiative called CYBERGAME in order to educate users to the matter of cybersecurity.

3.2 The use of the website does not require the processing of your personal data. The user will be free to choose a nickname that will be used by CRIF for the sole purpose of drawing up a ranking. At the end of the quiz and with your consent, you can choose to transmit the following data: "name, surname and email", in order to obtain informational material by CRIF.

### **4. Purposes of the processing**

Your personal Data will be processed for the following purposes:

- a) in order to send informational material, in particular PDF, containing guidelines regarding the phenomenon of phishing;
- b) your personal Data will also be collected compliance purpose, seen the legal obligations to which CRIF S.p.A. is subject in accordance with art. 6 par. 1 lett. c) of the GDPR.

### **5. Lawfulness of the processing**

The lawfulness of the processing of Your personal Data, in regards to the informational material sent in a PDF form, resides in Your freely given, specific, informed and unambiguous consent, as stated under article 6 par. 1 lett. a) of the GDPR. The personal Data collected and processed for the purpose under paragraph 4, lett. a) will be canceled after the PDF file is sent.

The legal basis of the processing of Your personal Data for legal compliance purposes (par. 4, lett. b)) resides in art. 6, par. 1 lett. c) of the GDPR. The date will be stored for the time required by law or necessary for the defense of rights.

### **6. Recipients or categories of Recipients of the personal Data and extra EU transfer**

Your personal Data will be processed exclusively by persons authorized and legal entities instructed under article 28 and 29 of the GDPR, such as: a) subjects which carry out support activities and maintenance of the CYBERGAME website.

You can find the list of the Processors at the Controller's location in Via della Beverara 21, 40131 Bologna.

Your personal Data collected and processed will not be transferred outside of the European Union.

### **8. Rights of the Data Subject**

Pursuant the GDPR, the Data subject shall have the following rights:

- the right to obtain confirmation as to whether or not Your personal Data are being processed, and, where it is the case, access to the personal Data and the following information (purposes of the processing; the categories of personal Data concerned; the recipient or categories of recipient; the personal Data retention etc);
- the right to obtain the rectification of inaccurate personal Data;
- taking into account the purposes of the processing, the right to have incomplete personal Data completed, including by means of providing a supplementary statement;
- the right to obtain the erasure of Your personal Data;
- the right to obtain a restriction of processing under article 18 of the GDPR;
- if applicable, the right to receive Your personal Data in a structured, commonly used and machine-readable format and have the right to transmit those Data to another controller; the right to have the personal Data transmitted directly from one controller to another, where technically feasible;
- the right to object at any time to the processing of Your personal Data.

You, as the Data subject, may exercise your rights under the GDPR in respect of and against each of the controllers.

You, as the Data subject, have the right to lodge a complaint with the competent Supervisory Authority, following this link:
